INTRODUCTION

Main Group FX is a trading name for MAIN GROUP FX PTY LTD.

MAIN GROUP FX PTY LTD is a company registered and authorized under the Australian Securities and Investments Commissions, under ACN 665 904 236, ABN 44 665 904 236 with a registered office at 465 Victoria Ave, Chatswood, NSW 2067, Australia.

This document presents our terms and conditions for our Refer-a-Friend Program, referred to as the "Terms" which apply to MAIN GROUP FX PTY LTD, in which the following terms "we", "us", "the company" or "Main Group FX" are used to refer to MAIN GROUP FX PTY LTD and its related companies.

"Referrer" applies to any existing Main Group FX client that will participate in the Program, while "Referred Friend" will apply to any new client referred to us by the Referrer.

By participating in this Program, both the "Referrer" and the "Referred Friend" are deemed to accept and follow the terms of this Agreement.

The Program is valid from the 18th of July 2023 and will remain valid under further notice.

CRITERIA FOR ELIGIBILITY

1. In order for the Referrer to be eligible for the Reward offered under this Program, the following criteria must be met:

a) The Referrer must:

- i. be a direct client of Main Group FX;
- ii. not promote themselves as an agent, IB or Affiliate of Main Group FX;
- iii. not be an employee of Main Group FX or their immediate families;

b) The Referred Friend must:

- i. be over 18 years old and have a fully verified account according to our KYC procedure;
- ii. be a new client of Main Group FX without any prior history of holding an Account with Main Group FX or any other entity affiliated with Main Group FX;

- iii. fund their account with the minimum required amount of \$1000;
 - iv. close a minimum of 2 lots worth of trading volume;
2. Main Group FX reserves the right to exclude any individual or application from this Program, and has no obligation to provide any justification.
 3. In order for any trade to be considered eligible for this promotion, it needs to be open for a minimum of 5 minutes.
 4. Once a Credit Cash Reward is added to an Account, it is required that both the Referrer and the Referred Friend do not have any pending withdrawal or account closure requests. The credited cash reward will be exclusively deposited into the Account, and no alternative payment method will be entertained.
 5. Main Group FX retains the authority to subtract the Reward Cash Credit from an Account in the event of withdrawal or termination of the Account within 30 calendar days from the initial crediting of the Credit. Once the 30-day period has elapsed since the Reward Cash Credit was added, if the minimum volume requirement was met, the Referrer may proceed to withdraw the amount as cash without any restrictions.
 6. Main Group FX will not assume any responsibility for any losses incurred by the Referred Friend due to trades executed on their Account, regardless of the circumstances.
 7. The Referrer and the Referred Friend shall indemnify and safeguard Main Group FX, along with its affiliates, officers, and employees, against any claims, demands, expenses, or damages arising from their violation of these Terms.
 8. Main Group FX reserves the right to amend the Terms of this Agreement at any time and without prior notice.

CREDIT REWARDS

Provided that all the Terms of the Program are met, the Referrer has the opportunity to accumulate Reward Cash Credits in their Main Group FX Account for every Referred Friend according to the following guidelines:

- a) \$500 for each Referred Friend that deposits a minimum amount of \$1000;
 - b) 0.5% of the total Contract value of the deposit added under the Main Group FX Investment Agreement, for any deposit starting from \$25,000 and up to \$1.5 Million;
 - c) 1% of the total Contract value of the deposit added under the Main Group FX Investment Agreement, for any deposit above \$1.5 Million;
- The funds will be allocated to the Referrer's account within a period of 10 working days from the moment the Referred Friend has met the minimum requirements mentioned in Clause 1.



GOVERNING LAW

The laws of the State of New South Wales shall govern the Agreement on these Terms and Conditions and all transactions that are a part of it, as well as its interpretation. The Parties consent to the courts and tribunals in that State's non-exclusive jurisdiction.
